**RE: Inflation Relief Subsidy**

To: All Dene Tha First Nation Registered Members

In the past couple of months, our Nation and its members have been hit hard with the rising costs of energy, food, and fuel. Dene Tha First Nation will be providing all our registered members with a one-time Inflation Relief Subsidy:

- DTFN Members who are 18 years of age and older will receive \$1000.00 per adult.
- DTFN Members 17 years of age and under will also receive \$500.00 per child, payable to the parent/legal guardian.

Each adult in a family needs to submit a form but only one parent can receive the subsidy for the children.

The Inflation Relief Subsidy will be issued to all living, registered DTFN Members as of December 8, 2022, and will be released on December 16 & 19, 2022, by either cheque or direct deposit. Deadline to submit is December 14, 2022.

# Commonly Asked Questions:

**Who can receive the subsidy?**

Both on and off [registered DTFN Members](#)

**When is the deadline for submission?**

All applications are to be emailed or dropped off by December 14, 2022

**What if a child is born after the form has been submitted?**

Only members that are registered with the nation before the deadline, are eligible for the Inflation Subsidy.

**When can I expect a payment?**

Payments will be available on December 16 & 19, 2022 by either cheque or direct deposit.

**What if I do not have a bank account?**

A cheque will be issued

**What if I cannot contact support by phone?**

Send an email with your question to the provided contacts on the letter.

**Who will assist our elders or members living in long term care homes?**

Someone will be appointed in each community.

**I have a child registered with another Nation; can they be issued the subsidy?**

Unfortunately, no, benefit is only for registered Dene Tha First Nation Members.
